What is New INDIGO?

New INDIGO is a consortium of European and Indian S&T organisations involved in promoting research cooperation between Europe and India. It is intended to strengthen the international dimension of the European Research Area (ERA) by providing a networking platform for Indian and European S&T organisations.



New INDIGO is expected to

- Build a multilateral consortium model based on experience involving the implementation of bilateral S&T programs between EU countries and India.
- Design a strategy to foster long-term scientific collaboration between European and Indian stakeholders, including research institutes, academia, industry, and government.
- Create a relevant framework to allow the scientific community of India to access the ERA, and the Euro-India S&T cooperation to fully benefit from networking tools such as FP7 and the Networking Pilot Program (NPP).
- Mapping and benchmarking Indian and European research hotspots.
- Develop an effective system to communicate networking opportunities and foster the exchange of ideas.
- Structuring the international dimensions of the ERA, through exchange of information, expertise, and best practices, including the development of databases.
- Empower stakeholders to explore and effectively use all networking tools to enhance interactions between European and Indian research.
